#### **PAYMENT METHODS AVAILABLE**

Some members have reported problems when trying to make online payments to the club, particularly around the account holder name which some of the banks suggest does match the sort code / account number details, this is the banks way of helping to prevent fraudulent transactions. The clubs account details are as follows:

There may be some instances where the bank will restrict the number of characters you can enter for the account name. In this case use NHAEG and it should work, but the bank may warn you that this account name is not recognised. However, as long as you have entered the correct sort code and account number as above, payment will still come through to the club.

### **Classics and Modern Fuel**



Much has been written about modern fuels and their ethanol content, but the above picture provides visible proof that it degrades. The jar on the left contains fresh petrol, the middle one is a few months old and the one on the right has been in a tank for many years. The issue affects carburettor fed engines far more than fuel injection cars.

Modern fuels will simply degrade and are not meant to have a long shelf life. Ethanol based fuel is said to have a shelf life of only 3 to 6 months, which can lead to poor starting. Fuel in the float chamber evaporates and the residues will harden over time. The deposits can then restrict fuel flow which results in poor running.

The problem is caused by water vapour combining with the ethanol in the fuel tank, which becomes slightly acidic. This then results in it separating from the fuel mix and settling at the bottom of the tank, ultimately causing rust in the fuel tank.

If you are storing your classic for any length of time the options are:

- Empty the tank not always easy
- Fill the tank to the brim to minimise the surface area of fuel that can interact with water vapour in the air

- Wrap cling film around the filler cap and breather to prevent water vapour entering the tank.
- Check that fuel hoses are rated to E10 specification and are not showing any signs of deterioration.
- The use of additives which are claimed to stabilise the fuel and slow its degradation. These may also be combined with unleaded fuel additives.

Finally a pending issue is the future of E5 super unleaded fuel which was intended as a temporary 'protection' grade and will be the subject of a review by the next Government. Synthetic fuels could become available in order to meet the ever increasing legislation on emissions and air quality, but at what cost per litre?
